

## Terms of Service:

The following terms and conditions govern all use of the TeachAntiBullying.org website and all content, services and products available at or through the website (taken together, "The Website"). The Website is owned and operated by Teach Anti Bullying Inc. ("Teach Anti Bullying"). The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Teach Anti Bullying's Privacy Policy) and procedures that may be published from time to time on this Site by Teach Anti Bullying (collectively, the "Agreement").

Please read this Agreement carefully before accessing or using the Website. By accessing or using any part of the web site, you agree to become bound by the terms and conditions of this agreement. If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties' original intent, and the remaining portions will remain in full force and effect. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. You may assign your rights under this Agreement to any party that consents to, and agrees to be bound by, its terms and conditions; Teach Anti Bullying may assign its rights under this Agreement without condition.
